



## Terms and Conditions for "Zero Commission Campaign"

**Introduction:** Welcome to our "Zero Commission Campaign" ("Campaign") brought to you by LiveChat, Inc. with its principal office at 101 Arch Street, 8th Floor, Boston MA 02110, United States of America. By participating in this Campaign, [developers](#) have the unique opportunity to earn 100% of the revenue from sales of their [applications](#) published on our [Marketplace](#) ("Participants"), subject to the terms set forth herein.

**Eligibility:** To participate, developers must submit their applications for review by January 31, 2024 ("Submission Deadline"). Applications submitted after the Submission Deadline will not qualify for the benefits of this Campaign.

**Zero Commission Period:** Participants whose applications are successfully reviewed and published on our Marketplace will be eligible for a zero commission rate for sixty (60) days ("Initial Zero Commission Period") following the date of publication, during which they will receive 100% of the revenue from the sales of their applications on their developer account.

**Featured Placement and Support:** Applications under this Campaign will receive featured placement on our [Marketplace](#) and in LiveChat Agent App, granting them greater visibility to potential customers. Participants will also have priority access to support via our dedicated Discord server.

**Bonus Rewards:** Participants have the opportunity to extend their Zero Commission Period by achieving the following milestones:

- a. First 10 sales: An additional fourteen (14) days of zero commission upon reaching the first 10 sales of the Campaign application.
- b. Three 5-star reviews: An additional one (1) month of zero commission if the application receives at least three 5-star reviews before the end of the Initial Zero Commission Period.
